

PALO PINTO COUNTY JUVENILE BOARD MEETING

August 21, 2024

The Juvenile Board of Palo Pinto County met in regular session on August 21, 2024. Members present were Shane Long, County Judge and Mike Moore, District Judge. Also, in attendance were Palo Pinto County Auditor, Melissa Mahan, and Juvenile Probation Officer, Marlin Price.

1. Call to Order;

Judge Long called the meeting to order at 8:16 a.m.

2. Public Discussion on current agenda items;

No one from the public was present. Thus, no public discussion on current agenda items occurred.

3. Consider/Approve minutes of the August 7, 2024 Juvenile Board Meeting;

Judge Moore made a motion to approve the minutes.

Judge Long seconded the motion.

A vote was taken.

The motion was approved, 2-0.

4. Consider/Approve changes to Juvenile Department Policy and Procedures Manual;

Officer Price presented Juvenile Board Members with information that needed to be added to the Juvenile Department Policy and Procedures Manual as determined by the Texas Juvenile Justice Department in a recent audit.

The following information needs to be added.

Pretrial Detention for Certain Juveniles

The District Judge will decide if an individual who is certified as an adult and is under 17 years of age is detained at a juvenile facility or the county jail on a case by case basis.

Judge Moore made motion to approve the proposed changes to the Juvenile Department Policy and Procedures Manuel.

Judge Long seconded the motion.

A vote was taken.

The motion was approved, 2-0.

5. Consider/Approve Contracts;

Officer Price presented the Juvenile Board with two contracts for consideration. These contracts were for Rite of Passage-Lake Granbury Youth Services Pre-Adjudication (Detention) Facility and Tom Green County Juvenile Detention Center.

Judge Moore made a motion to approve these contracts subject to review by the County Attorney.

Judge Long seconded the motion.

A vote was taken.

The motion was approved, 2-0.

6. Budget Amendments;

Auditor Mahan presented the Juvenile Board with a budget amendment to move some money around to take care of expenses including detention,

car maintenance, and supplies. Auditor Mahan explained that this money would be coming out of state funds.

Judge Long made a motion to approve this budget amendment.

Judge Moore seconded the motion.

A vote was taken.

The motion was approved, 2-0.

7. Adjournment;

Judge Moore made a motion to adjourn.

Judge Long seconded the motion.


A vote was taken.

The motion was approved, 2-0.

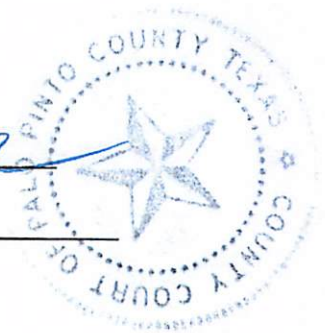

The meeting was adjourned at 8:20 a.m.
